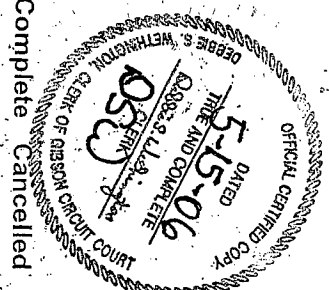


State of Indiana Voter Status Counts by Precinct
