The Huntington County Election Board met on today's date at 12:00 p.m. to count the provisional ballots and to determine if in fact any of the provisional ballots should be deemed valid.

The meeting was posted as required. Present were Carmen K Oswalt, President, Carol Grove, Board Member & Vicki Stoffel, Secretary. Oaths as provisional counters were given to Carmen & Carol.

There were four provisional ballots cast and locked in the election cabinet. The individuals that cast these ballots had 10 days from May 2, 2006 to provide the required documentation to the County Clerk's office. All ballots were reviewed along with any documentation provided. It is the determination of the Election Board that one provisional ballot may be considered valid. After adding the selected votes from the ballot, a new precinct summary & election summary were ran.

On the issue of the tie race in School Board District 5, the totals remain unchanged. The votes are as follows: Homer J. (Burny) Burnworth-171 votes & Thomas R. (Tom) King-171 votes.
